CONTINUATION OF RENT

LESSEE:

Mercedes See

AREA, LAND TYPE, AND LOCATION:

0.034 acres, more or less, of sovereign lands in the Petaluma River, at Lakeville,
Sonoma County.

AUTHORIZED USE:

Continued use and maintenance of a deck, walkway, and a boat dock.

LEASE TERM:

Ten years, beginning July 1, 1999.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff has conducted a review of the rent under
this lease, and recommends that rent be continued at \$170 per year, effective
July 1, 2005.

OTHER PERTINENT INFORMATION:

On December 3, 1999, the Commission authorized a General Lease –
Recreational Use to Mercedes See for the continued use and maintenance of the
deck, walkway, and boat dock. The Lessee has the right to use the uplands
adjoining the lease premises, located in the Petaluma River, near Lakeville, in
Sonoma County.




Exhibit A
