**REVISION OF RENT**

**LESSEE:**

Marin Rowing Association, a non-profit corporation

**AREA, LAND TYPE, AND LOCATION:**

0.08 acres, more or less, of sovereign lands in Corte Madera Creek, city of Larkspur, Marin County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing pier, ramp, and a floating boat dock and maintenance dredging.

**LEASE TERM:**

Ten years, beginning September 1, 1997.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that rent be revised from \$170 per year to \$212 per year, effective September 1, 2005.

**OTHER PERTINENT INFORMATION:**

1. The Applicant has the right to use the upland adjoining the lease premises located in the Corte Madera Creek, city of Larkspur, in Marin County.
2. On July 11, 1997, the Commission authorized a General Lease – Recreational Use to Marin Rowing Association, a non-profit corporation for the continued use and maintenance of a pier, a ramp, and a floating boat

dock. Marin Rowing Association uses the pier, ramp, and dock for purposes of conducting competitive boat-rowing training.




