RECREATIONAL PIER LEASE

APPLICANTS:

Gregory A. Cruz and Gladys Cruz

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Georgiana Slough, city of Isleton, Sacramento County.

AUTHORIZED USE:

Use and maintenance of an uncovered floating boat dock, gangway, walkway, and pilings.

LEASE TERM:

Ten years, beginning August 8, 2005.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Applicants own the upland adjoining the lease premises.
2. An uncovered floating boat dock, walkway, gangway, and pilings were constructed at this site in the 1980s. Over the years, staff was unsuccessful in bringing the facilities under lease. The applicants recently purchased the property and have applied for a lease. Applicants qualify for a Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the

staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




