**RECORD OF ACTION TAKEN BY THE  
CALIFORNIA STATE LANDS COMMISSION  
MEETING OF AUGUST 8, 2005**

Calendar Item C30 and Regular Calendar Item 65 were removed from the agenda to be heard at a subsequent meeting. Calendar Item C44 was moved to the regular calendar.

Calendar Item 52 was moved from consent and considered at the beginning of the meeting. Commissioners listened to a staff report and speakers on the acceptance of offers to dedicate in the City of Malibu. The item was approved as presented by a vote of 3-0. After a brief recess, the meeting was reconvened.

The recommendation of staff, relative to Calendar Items C01-C29, C31-C43, C45-C 51 and C53-C63 were approved by unanimous vote of Commission Chair Cruz M. Bustamante, Cindy Aronberg representing the Controller; and Anne Sheehan representing Department of Finance.

**Item 44:** The Commission listened to a staff report on an EIR assessment and application for a lease pertaining to El Paso Natural Gas Corporation. The item was approved by a 3-0 vote with the following conditions:

1. El Paso agrees to allow PG&E to connect its natural gas system to Line 1903, such connection to be in the vicinity of Cadiz or other mutually agreeable site, and El Paso will cooperate with PG&E in construction of the physical improvements.
2. PG&E will be responsible for paying all these costs associated with the interconnection.
3. PG&E will be responsible for obtaining all permits and approvals necessary to construct the interconnection
4. El Paso agrees not to oppose PG&E's efforts to secure all necessary approvals and permits to implement the connection.
5. Those foregoing terms will be included in the provision of the State Lands Commission's leases to El Paso in a form to be approved by Commission staff.

**Regular Item 66:** Commission staff listened to a staff report on the installation of a research cable in Monterey Bay and was asked to approve an EIR and to issue a general lease. The item was approved as presented by a 3-0 vote.
