**CONSIDER APPROVAL OF A NON-EXCLUSIVE GEOLOGICAL
SAMPLE PERMIT ON DESIGNATED TIDE AND SUBMERGED LANDS
UNDER THE JURISDICTION OF THE
CALIFORNIA STATE LANDS COMMISSION**

BACKGROUND:

The geological sampling authorized under the terms of the permit is for the purpose of obtaining shallow samples of the beds of Carquinez Strait and San Francisco Bay for geotechnical information. The data obtained will be used in the design, routing, and environmental documentation of a proposed 400 mw High Voltage Direct Current (HVDC) cable connecting existing electrical substations in the City of Pittsburg, Contra Costa County and Potrero Point in the city and County of San Francisco. The initial 36 shallow samples will be collected at 36 locations, as generally depicted on Exhibit A (attached hereto) and as specifically described in Exhibit A-1 (attached hereto), with up to but not exceeding 50 additional samples located within a radius of 1,000 feet from the defined 36 locations, utilizing vibrocore sampling methods from a self-contained vessel. The vessel is typically no larger than a fishing boat (usually 50 to 150 feet in length, with a six-foot draft). No activity or method employing rotary drilling operations is authorized by this permit. The Commission will be entitled to receive copies of all data derived from any and all surveys under the permit.

TERMS OF PROPOSED PERMIT:

Initial period:

Two years beginning September 6, 2005 through September 5, 2007.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 6, Information Collection; Title 2, California Code of Regulations, section 2905(e)(3).

Authority: Public Resources Code section 21084, Title 14, California Code of Regulations, section 15300, and Title 2, California Code of Regulations, section 2905.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370, et. seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.



TRANS BAY CABLE LLC., SEDIMENT SAMPLING LOCATIONS


