**AMENDMENT OF GENERAL LEASE - PUBLIC AGENCY USE**

**LESSEE:**

Department of Transportation  
2800 Gateway Oaks Drive  
Sacramento, CA 95833

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in the Bear River, near the town of East Nicolaus, Sutter and Yuba counties.

**AUTHORIZED USE:**

To widen, use and maintain the existing State Route 70 bridge and to construct, use and maintain a new parallel bridge.

**LEASE TERM:**

Continuous use plus one year beginning August 17, 2004.

**CONSIDERATION:**

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

**PROPOSED AMENDMENT:**

To authorize the use of a temporary construction right of way and the placement, use and removal of a temporary bridge crossing within the construction right of way during the construction period of the State Route 70 bridge widening project as shown on the attached Exhibit A. All other terms and conditions of the lease shall remain in effect without amendment.

**OTHER PERTINENT INFORMATION:**

1. Lessee owns or has the use of the uplands adjoining the lease premises.

2. On August 17, 2004, the Commission approved a lease pursuant to Section 101.5 of the Streets and Highway Code for the State Route 70 (SR 70) highway upgrade and bridge-widening project. The highway upgrade project consists of widening SR 70 to a four-lane expressway/freeway for a distance of 15.5 miles, which creates a four-lane freeway facility from Marysville to Sacramento. The existing two lane bridge will be widened by eight feet to create a one-way bridge and a new parallel two lane bridge will be constructed to the east of the existing bridge. The project includes the placement and use of a temporary bridge crossing structure during the construction period for use by construction vehicles and equipment. The bridge will be removed and the disturbed area restored after construction is complete.
3. The August 17, 2004, Commission approval did not include authorization of the temporary construction right of way and the bridge crossing portion of the project and staff is now recommending approval of the amendment to include the temporary construction area and the placement, use and removal of the temporary bridge crossing.
4. On September 21, 2005, the Region 2 Manager of the Department of Fish and Game (DFG) executed a "conditioned" Streambed Alteration Agreement (Agreement) with CalTrans that governs the proposed placement and use of a temporary bridge crossing within the construction right-of-way of the SR 70 bridge widening project over the Bear River. While the DFG initially determined that such operations "may substantially affect existing fish and wildlife resources including: Giant Garter snakes; Central Valley steelhead; Central Valley fall/late fall-run Chinook salmon; cliff swallows; Swainson's hawks; warm water fish species, amphibians and other aquatic and terrestrial plant and wildlife species," it proposes measures within the Agreement to protect fish and wildlife during the CalTrans project. All conditions specified by the DFG have been accepted by CalTrans.
5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA under the general rule that the CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes, based on the information available to it,

that there is no possibility that this project may have a significant effect on the environment.

Authority: Title 14, California Code of Regulations, section 15061 (b) (3).

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




TEMPORARY CONSTRUCTION RIGHT OF WAY
