REVISION OF RENT

LESSEE:

Ridgewood Property Owners Association
P.O. Box 220
Carnelian Bay, CA 96140

AREA, LAND TYPE, AND LOCATION:

0.475 acres, more or less, of sovereign lands in Lake Tahoe, near Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier, 15 mooring buoys and one swim float as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning September 29, 1998.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$93 per year to \$159 per year, effective September 29, 2006.

OTHER PERTINANT INFORMATION:

1. Lessee owns the upland property adjacent to the Lease Premises.
2. Lessee is a property owners association consisting of 53 member lots. Of these 53 member lots, two are not natural persons and do not qualify for rent-free status pursuant to Section 6503.5 of the Public Resource Code. The annual rent is therefore prorated according to the percentage that does not qualify for rent-free status.






BUOY FIELD


LOCATION
