State Controller Steve Westly, Chair, called the regular meeting of the California State Lands Commission to order at 10:06 a.m., at Nile Hall, Preservation Park, 668 13<sup>th</sup> Street, Oakland, California 94612.

The minutes of the April 17, 2006 meeting were approved by a vote of 3-0.

Calendar Items C73, C84 and C85 were removed from the agenda to be heard at a subsequent meeting. Regular Item 86 was deferred.

The recommendation of staff, relative to Calendar Items C01-C72 and C74-C83, were approved by unanimous vote of Commission Chair Steve Westly, representatives Lorena Gonzalez and Anne Sheehan.

**Regular Item 86:** The Commission listened to a staff presentation pertaining to the consideration of a financial review and legislative grant to the City of Redondo Beach. The Commission decided to postpone this item until various issues could be further investigated.
