RECREATIONAL PIER LEASE

**APPLICANTS:**

Donald A. Murphy and Pamela J. Murphy, Trustees of the Murphy Family Trust  
dated February 26, 1998

**AREA, LAND TYPE, AND LOCATION:**

0.0279 acres, more or less, of sovereign lands in the Sacramento River, in the  
Pocket area, in the city of Sacramento, Sacramento County.

**AUTHORIZED USE:**

Construction, use, and maintenance of a new single-story covered floating boat  
dock with a pitched roof, walkway from the dock to the shore, and pilings as seen  
in Exhibit A.

**LEASE TERM:**

Ten years, beginning August 24, 2006.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance with coverage of no less than \$300,000.

**OTHER PERTINENT INFORMATION:**

1. Applicants own the uplands adjoining the lease premises.
2. The Applicants have applied to install four pilings and construct a single-  
story floating boat dock that will be covered with a pitched roof. Access to  
the floating dock will be provided via a walkway (gangway) that will be  
constructed from the Applicants' upland property to the dock.

3. Applicants qualify for a rent free boat dock, walkway and pilings because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.
4. On June 26, 2006, the Commission approved Calendar Item # 33 for the emergency repair of eight levee sites within the Pocket Area of the city of Sacramento. In the event the dock site is affected by these levee repairs, the Applicants will not be allowed to construct their dock until the emergency repairs to the levee at this site have been completed.
5. The design of the boat dock has been modified. No construction shall commence until all applicable permits are amended and approvals obtained from the agencies having jurisdiction over this project, and copies of such permits are provided to the Commission.
6. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 3, New Construction of Small Structures; Title 2, California Code of Regulations, section 2905 (c)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

7. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.





CROSS-SECTION ELEVATION VIEW




TOP OF THE LEVEE
