REVISION OF RENT

LESSEE:

Sierra Boat Company, Inc.
PO Box 69
Carnelian Bay, CA 96140

AREA, LAND TYPE, AND LOCATION:

0.566 acres, more or less, of sovereign lands in Lake Tahoe, Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use, operation and maintenance of a commercial dock/breakwater, a fueling facility and 15 mooring buoys as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning July 11, 2002.

CONSIDERATION:

This lease provides that Lessor may modify the minimum annual rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the minimum annual rent under this lease, and recommends that the minimum annual rent be revised from \$3,960 per year to \$7,935 per year, effective July 11, 2007.




SITE MAP
