RECREATIONAL PIER LEASE

APPLICANTS:

Peter Alfons Mentges and Nina Maria Mentges, trustees of the Peter Alfons Mentges and Nina Maria Mentges 1984 Family Trust dated June 26, 1984

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, located near South Lake Tahoe, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning August 21, 2007.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Applicants own the upland adjoining the lease premises.
2. On July 11, 1997, the Commission authorized a ten-year Recreational Pier Lease to Peter Alfons Mentges, as Trustee of the Peter Alfons Mentges and Nina Maria Mentges 1984 Family Trust. That lease will expire on August 20, 2007. The upland property has since transferred to Peter Alfons Mentges and Nina Maria Mentges, trustees of the Peter Alfons Mentges and Nina Maria Mentges 1984 Family Trust dated June 26, 1984. Applicants are now applying for a new Recreational Pier Lease.

CALENDAR ITEM NO. C03 (CONT'D)

3. The Applicants qualify for a rent free Recreational Pier Lease because they are natural persons who have improved the littoral land with, and use the upland for, a single-family dwelling.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

AUTHORIZE ISSUANCE TO PETER ALFONS MENTGES AND NINA MARIA MENTGES, TRUSTEES OF THE PETER ALFONS MENTGES AND NINA MARIA MENTGES 1984 FAMILY TRUST DATED JUNE 26, 1984, OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING AUGUST 21, 2007, FOR THE CONTINUED USE AND MAINTENANCE OF AN EXISTING PIER AS SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$300,000.



