GENERAL LEASE – GRAZING USE

APPLICANTS:

Sandra Braden, Paula Rosser and Bruce Jacobson, Successor Co-Trustees of the Henry and Dorothy Schechert Trust, dated March 24, 1982

AREA, LAND TYPE, AND LOCATION:

2,057 acres of State school and lieu lands ten miles north of Honey Lake, Lassen County.

AUTHORIZED USE:

Cattle grazing.

LEASE TERM:

Ten years, beginning April 1, 2007

CONSIDERATION:

\$500 per year; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

SPECIFIC LEASE PROVISIONS:

Combined single limit coverage of no less than \$1,000,000.

OTHER PERTINENT INFORMATION:

1. On October 28, 1996, the Commission authorized a General Lease – Grazing Use with Henry Schechert, Trustee of the Henry and Dorothy Schechert Trust. That lease expired March 31, 1996, and Sandra Braden, Paula Rosser and Bruce Jacobson, Successor Co-Trustees of the Henry and Dorothy Schechert Trust, dated March 24, 1982, Applicants are now applying for a new General Lease – Grazing Use.
2. There are no improvements on the State's property, which is not irrigated. Depending on winter rainfall and amount of feed available, cattle are grazed on the property for one to three months in the late spring or early

summer. The annual rent is based on the carrying capacity of the property, which is estimated to be 102 Animal Unit Months (AUM).

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land; Title 2, California Code of Regulations, section 2905 (d)(1).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission has declared that all tide and submerged lands are "significant" by nature of their public ownership (as opposed to "environmentally significant"). Since such declaration of significance is not based upon the requirements and criteria of Public Resources Code sections 6370, et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by Title 2, California Code of Regulations, section 2954 is not applicable.



AUTHORIZE ISSUANCE TO SANDRA BRADEN, PAULA ROSSER AND BRUCE JACOBSON, SUCCESSOR CO-TRUSTEES OF THE HENRY AND DOROTHY SCHECHERT TRUST, DATED MARCH 24, 1982, A GENERAL LEASE – GRAZING USE, BEGINNING APRIL 1, 2007, FOR A TERM OF TEN YEARS, FOR CATTLE GRAZING AS SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; ANNUAL RENT IN THE AMOUNT OF \$500, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENT PERIODICALLY DURING THE LEASE TERM, AS PROVIDED IN THE LEASE; LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$1,000,000.


SITE
