**REVISION OF RENT**

**LESSEE:**

TDB Sacramento Delta Corporation  
48 Chestnut Place  
Danville, California 94506-4542

**AREA, LAND TYPE, AND LOCATION:**

0.24 acres, more or less, of sovereign lands in Georgiana Slough, near the town of Isleton, Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing five-berth covered floating boat dock facility.

**LEASE TERM:**

Ten years, beginning May 1, 2003.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$969 per year to \$1,068 per year, effective May 1, 2008.

The recommended rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). The adjustment does not obligate the Commission to use the CPI to adjust future rents.

**OTHER PERTINENT INFORMATION:**

On October 20, 2003, the Commission authorized a ten-year General Lease – Recreational Use to TDB Sacramento Delta Corporation. The Lessee is a corporation that includes five owners who own the upland and use the docks. The lease expires on April 30, 2013.




### SITE
