**REVISION OF RENT**

**LESSEES:**

Wesley L. Boyd and Joan E. Blades, as Trustees of the Wesley Boyd and Joan Blades Family Trust dated May 24, 1993

**AREA, LAND TYPE, AND LOCATION:**

1.04 acres, more or less, of State school land in a portion of Section 25, Township 19 North, Range 12 West, MDM, near Foster Mountain, Mendocino County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing unpaved access road.

**LEASE TERM:**

25 years, beginning July 1, 2003.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$100 per year to \$197 per year, effective July 1, 2008.

**OTHER PERTINENT INFORMATION:**

1. On June 2, 2003, the Commission authorized a General Lease - Right of Way Use with Wesley L. Boyd and Joan E. Blades, as Trustees of the Wesley Boyd and Joan Blades Family Trust dated May 24, 1993. That lease will expire on June 30, 2028.
2. The Lessees own the land adjacent to the Lease Premises and use the unpaved road to access their property. The Lessees maintain the unpaved access road and assume all costs and expenses associated with road maintenance.

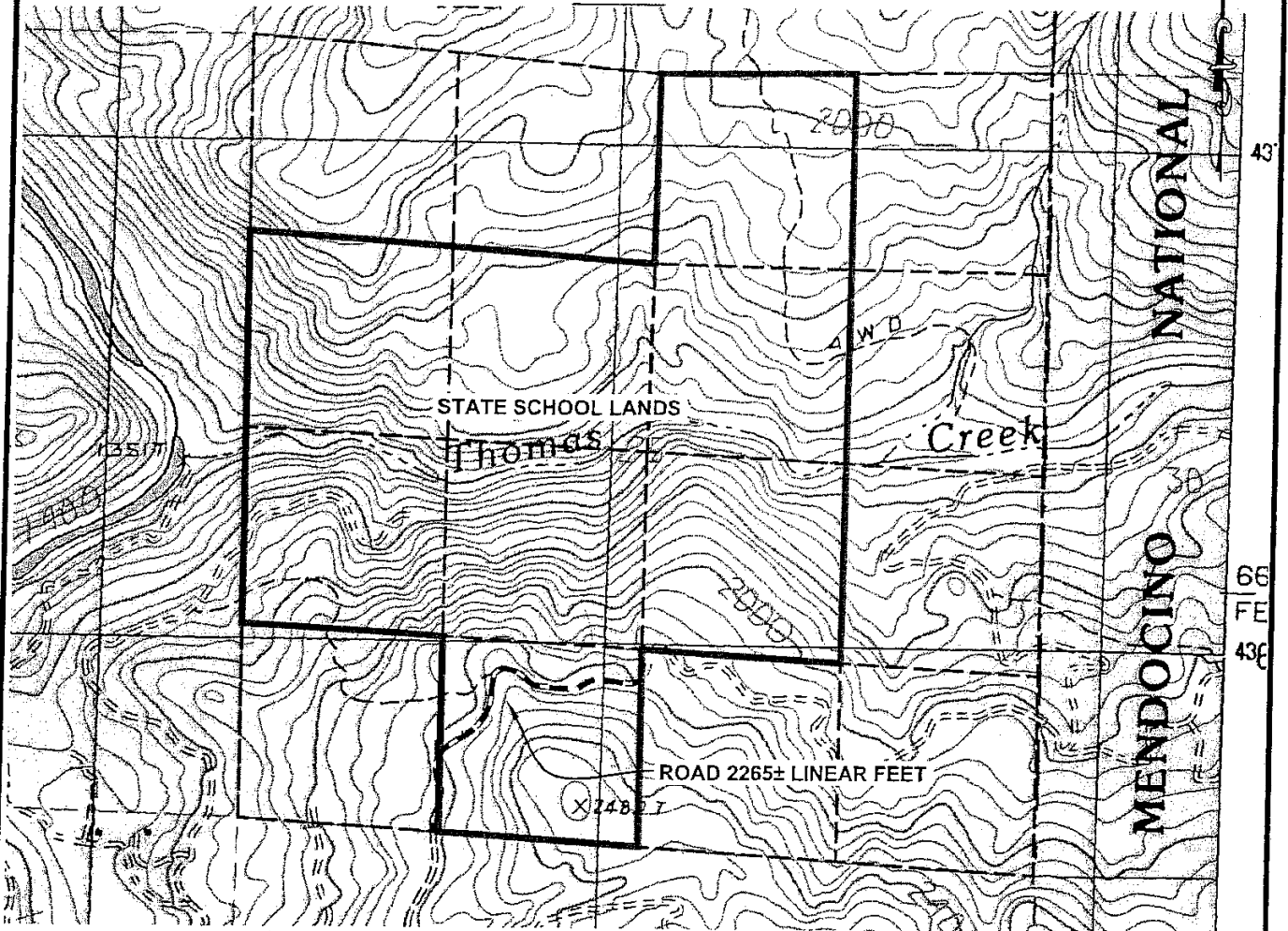

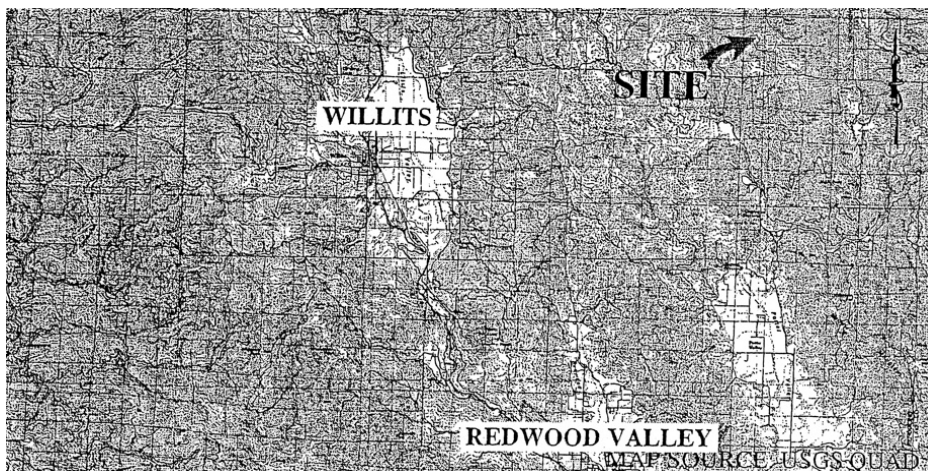
## SITE
