1. On June 19, 1998, the Commission authorized a ten-year commercial sand and gravel extraction lease, with an option to renew for an additional

ten years, to Bell Marine Co., Inc. On December 3, 1999, the Commission authorized the assignment of the Lease to RMC Pacific Materials, Inc. RMC Pacific Materials subsequently indicated their intent not to exercise their option to renew the Lease for an additional period of ten years.

Pursuant to the Commission's delegation authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15060 (c)(3), the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.




