CONTINUATION OF RENT

LESSEE:

Venice Island, Inc.
1440 Arundel Court
Lodi, California 95242-4503

AREA, LAND TYPE, AND LOCATION:

0.0514 acres, more or less, of sovereign lands in the San Joaquin River,
adjacent to 17500 W. Eight Mile Road, Venice Island, San Joaquin County.

AUTHORIZED USE:

Continued use and maintenance of an existing uncovered floating boat dock,
walkway, and ramp as shown on Exhibit A.

LEASE TERM:

Ten years, beginning August 1, 2003.

CONSIDERATION:

This lease provides that the Lessor may modify the rent periodically during the
lease term. Pursuant to this provision, staff has conducted a review of the rent
under this lease, and recommends that the rent be continued at \$384 per year,
effective August 1, 2009.

OTHER PERTINENT INFORMATION:

On August 1, 2003, the Commission authorized a General Lease - Recreational
Use to Venice Island, Inc. That lease will expire on July 31, 2013.




