#### RECREATIONAL PIER LEASE

#### **APPLICANTS:**

Charlotte F. Shea, as Trustee of The Charlotte F. Shea Revocable Trust dated June 18, 1992; Kevin E. Shea, Deborah M. Rowe, and Michael L. Shea

#### AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, adjacent to 3031 Jameson Beach Road, near the city of South Lake Tahoe, El Dorado County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier and one mooring buoy as shown on the attached Exhibit A

#### LEASE TERM:

Ten years, beginning May 1, 2009.

#### CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

#### **SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in the amount of no less than \$500,000.

#### Other:

- This lease contains a provision which requires the Applicants to obtain authorization from the Tahoe Regional Planning Agency for one mooring buoy within two years after the adoption of the Lake Tahoe Shorezone Amendments-Final Environmental Impact Statement (FEIS) and approval of the ordinances based on the FEIS.
- 2. The lease provides that the public will be allowed to pass and repass around the landward end of the pier to provide continuous shoreline access to the Public Trust Easement below elevation 6228.75 Lake Tahoe datum.

#### OTHER PERTINENT INFORMATION:

- 1. Applicants own the upland property adjoining the lease premises.
- 2. On June 14, 1999, the Commission authorized a Recreational Pier Lease with Charlotte F. Shea, as Trustee of the Charlotte F. Shea Revocable Trust dated June 18, 1992. That lease expired on April 30, 2009. Charlotte F. Shea, as Trustee, has since deeded a portion of her interest in the littoral land to Kevin E. Shea, Deborah M. Rowe, and Michael L. Shea. The Applicants are now applying for a new Recreational Pier Lease.
- 3. Applicants qualify for a Recreational Pier Lease because they are natural persons who own the littoral land that is improved with a single-family dwelling.
- 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

5. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.




