**ACCEPTANCE OF A PARTIAL QUITCLAIM DEED AND
AMENDMENT OF LEASE NO. PRC 8255.2 AND ISSUANCE
OF A NEW GENERAL LEASE - RIGHT OF WAY USE**

AREA, LAND TYPE, AND LOCATION:

Six parcels of School Lands containing a total of 40 acres, more or less, in Section 16, Township 5 North, Range 15 East, Section 36, Township 3 North, Range 12 East, Section 16, Township 9 North, Range 21 East, Section 36, Township 9 North, Range 20 East, Section 16, Township 8 North, Range 20 East, and Section 16, Township 7 North, Range 18 East, SBM, east of Twentynine Palms Marine Corps Air Ground Combat Center, San Bernardino County.

AUTHORIZED USE:

Use and maintenance of an existing 16-inch underground pipeline for transmission of natural gas, and two cathodic protection units.

LEASE TERM:

20 years, beginning December 1, 2000.

CONSIDERATION:

\$9,272 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

PROPOSED AMENDMENT:

Delete two of the six parcels comprising the lease premises located in Section 16, Township 5 North, Range 15 East and Section 36, Township 3 North, Range 12 East, revise the authorized improvements to delete one cathodic protection unit, and revise the annual rent to \$5,195, effective August 11, 2009. All other terms and conditions of the lease shall remain in effect without amendment.

PROPOSED NEW LEASE - AREA, LAND TYPE, AND LOCATION:

17.88 acres, more or less, of school lands in Section 16, Township 5 North, Range 15 East and Section 36, Township 3 North, Range 12 East, SBM, east of Twentynine Palms Marine Corps Air Ground Combat Center, San Bernardino County.

PROPOSED NEW LEASE - AUTHORIZED USE:

Use and maintenance of an existing underground 16-inch pipeline for the transmission of natural gas; removal of one existing block valve, replacement of one existing block valve, and upgrading of one existing cathodic protection rectifier.

PROPOSED NEW LEASE - TERM:

20 years, beginning August 11, 2009.

PROPOSED NEW LEASE - CONSIDERATION:

\$4,076 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

PROPOSED NEW LEASE - SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance of no less than \$5,000,000

Bond:

\$10,000

Other:

1. Applicant to perform all activities related to the Mitigation Monitoring Program for the North-South Interconnect Project, as prepared for and approved by the County of San Bernardino as an Addendum to the Questar Southern Trails Pipeline EIR/EIS (SCH# 99041103).

OTHER PERTINENT INFORMATION:

1. The Commission authorized the construction of a 16-inch underground petroleum pipeline in 1957. Seven leases were issued to Four Corners Pipeline Company for a period of 49 years each. On January 1, 1995, Four Corners Pipeline Company changed its name to ARCO Pipeline

Company (ARCO). The pipeline was used to transport crude oil until 1998.

2. On April 13, 1999, the Commission approved the assignment of the seven leases from ARCO to Questar Southern Trails Pipeline (Questar).
3. At its meeting of November 27, 2000, the Commission accepted lease quitclaim deeds to the seven leases, terminated the seven leases, authorized the issuance of Lease No. PRC 8255.2, a General Lease - Right of Way Use (Lease), to Questar, and authorized the conversion of the pipeline from petroleum to natural gas.
4. The lease premises consist of six parcels of school lands containing a total of approximately 40 acres.
5. Questar entered into a sales agreement with Southern California Gas Company (Applicant), whereby Questar would sell a portion of the pipeline to the Applicant. The portion of the pipeline to be sold consists of approximately 76 linear miles and includes two of the six parcels of school lands included within the lease premises for the Lease.
6. Questar has executed a Lease Quitclaim Deed to relinquish its leasehold rights in the two parcels that are proposed for sale to the Applicant.
7. Applicant applied for a new General Lease - Right of Way Use for the two parcels of school lands that are included in the proposed pipeline sale.
8. The current annual rent for Lease No. PRC 8255.2 is \$9,272 per year. Deletion of two of the six parcels from the lease premises will result in a new lease area of 22.12 acres, and therefore in a new annual rent of \$5,195.
9. For the two parcels of school lands containing that portion of the pipeline to be acquired by the Applicant, staff performed an appraisal for the purpose of establishing the rent for the new General Lease - Right of Way Use and recommends the rent be set at \$4,076 per year.
10. An Addendum was prepared by San Bernardino County for an EIR SCH #99041103 that was previously certified by the California State Lands Commission on November 27, 2000. The Addendum was approved by San Bernardino County on June 3, 2009. CSLC staff reviewed such document and Mitigation Monitoring Program prepared in

conformance with the provisions of the CEQA (Public Resources Code Section 21081.6) and adopted by the lead agency.

11. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. However, the Commission declared that all lands are “significant” by nature of their public ownership (as opposed to “environmentally significant”). Since such declaration of significance is not based upon the requirements and criteria of Public Resources code Sections 6370, et. seq., use classifications for such lands have not been designated. Therefore, the findings of the project’s consistency with the use classification as required by Title 2, California Code of Regulations, Section 2954 is not applicable.

PRC 8255.2, A GENERAL LEASE - RIGHT OF WAY USE, TO REVISE THE LEASE PREMISES TO THOSE SCHOOL LANDS SHOWN ON EXHIBIT C (FOR REFERENCE PURPOSES ONLY) AND DESCRIBED ON EXHIBIT D, BOTH ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; REVISE THE AUTHORIZED IMPROVEMENTS TO INCLUDE THE EXISTING 16-INCH UNDERGROUND PIPELINE AND ONE CATHODIC PROTECTION UNIT, AND REVISE THE ANNUAL RENT TO \$5,195, EFFECTIVE AUGUST 11, 2009; ALL OTHER TERMS AND CONDITIONS OF THE LEASE WILL REMAIN IN EFFECT WITHOUT AMENDMENT.








