**RECREATIONAL PIER LEASE**

**APPLICANTS:**

Ken Christie, Gail Christie, Ross A. Robinson and Vicki J. Robinson

**AREA, LAND TYPE, AND LOCATION:**

Sovereign lands in Lake Tahoe, adjacent to 3990 North Lake Boulevard, near Carnelian Bay, Placer County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing pier as shown on the attached Exhibit A.

**LEASE TERM:**

Ten years, beginning March 23, 2009.

**CONSIDERATION:**

No monetary consideration pursuant to Public Resources Code section 6503.5.

**SPECIFIC LEASE PROVISIONS:**

Liability insurance in the amount of no less than \$500,000.

**OTHER PERTINENT INFORMATION:**

1. On December 3, 1999, the Commission authorized a Recreational Pier Lease with James E. Keil and Nancy E. Keil, Trustees of the J. and N. Keil Family Revocable Trust dated January 22, 1997, and Ross A. Robinson and Vicki J. Robinson. That lease expired on March 22, 2009. In 2005, the Keils' 50 percent interest in the upland parcel was deeded to Ken Christie and Gail Christie. Applicants are now applying for a new Recreational Pier Lease.
  
2. Applicants qualify for a Recreational Pier Lease because they are natural persons who own the littoral land that is improved with a single-family dwelling.

3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a)(2).

Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
