CONTINUATION OF RENT AND AMENDMENT OF LEASE

LESSEE:

Sprint Communications Company L. P. 6391 Sprint Parkway
Mail Stop KSOPHT0101-Z2040
Overland Park, Kansas 66251

AREA, LAND TYPE, AND LOCATION:

Five parcels of State school and lieu land containing 3.16 acres, more or less, in a portion of Sections 30 and 31, Township 10 North, Range 1 East; Section 36, SBM, Township 15 North, Range 9 East; Tract 37, SBM, Township 16 North, Range 11 East, SBM; and Lot 1, Section 16, Township 16 North, Range 13 East, SBM, near Barstow, San Bernardino County.

AUTHORIZED USE:

Operation, use and maintenance of an existing underground fiber optic communications cable.

LEASE TERM:

30 years, beginning May 9, 1988.

CONSIDERATION:

This lease provides that the Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$400 per year, effective May 9, 2009.

PROPOSED AMENDMENT:

Delete and replace the land description contained in Section 3 of the lease with the land descriptions and site and location maps which are attached hereto as Exhibit A-1, B-1; A-2, B-2; A-3, B-3; A-4, B-4; and A-5,B-5; All other terms and conditions of the lease shall remain in effect without amendment.

OTHER PERTINENT INFORMATION:

- On May 9, 1988, the Commission authorized a General Lease Right of Way Use with U.S. Sprint Communications Company, for the installation of a fiber optic cable that crosses State school and lieu lands. Subsequently, on December 13, 1988, the Commission authorized an assignment of the lease to U.S. Sprint Communications Company Limited Partnership. In addition, the name of the business entity has since changed to Sprint Communications Company L.P. The lease will expire on May 8, 2018.
- 2. Pursuant to the terms of the Lease, after the fiber optic cable was installed, "as built" drawings and legal descriptions were to be provided to confirm the location of the cable. This information has been submitted and reviewed by Commission staff who have determined that the cable was placed outside of the lease premises previously approved by the Commission. Therefore, the lease description needs to be amended to authorize the "as-built" location of the cable.
- 3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines [Title 14, California Code of Regulations, section 15060(c)(3)], the staff has determined that this activity is not subject to the provisions of the CEQA because it is not a "project" as defined by the CEQA and the State CEQA Guidelines.
 - Authority: Public Resources Code section 21065 and Title 14, California Code of Regulations, sections 15060 (c)(3) and 15378.
- 4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.





PORTION OF SECTION 30 T10N, R1E, SBM

















