## CONSIDER ACCEPTANCE OF FULL QUITCLAIM DEEDS OF COMPENSATORY AGREEMENT PRC 3650.1, GILL RANCH GAS FIELD, FRESNO AND MADERA COUNTIES

### AREA, LAND TYPE AND LOCATION:

The California State Lands Commission (Commission) entered into Compensatory Agreement PRC 3650.1 (Agreement PRC 3650.1) to receive compensation from wells draining natural gas from State sovereign lands (a portion of the San Joaquin River) within the Gill Ranch Gas Field. The State lands are located about twenty miles west of the City of Fresno in Sections 21 and 22, T13S, R16E, MDB&M, Fresno and Madera Counties.

### **BACKGROUND:**

Agreement PRC 3650.1 was originally issued by the Commission to Shell Oil Company on October 27, 1966. Agreement PRC 3650.1, dated November 28, 1966, does not allow for any surface or subsurface use of State lands nor does it allow for any mineral development of or entitlement to State lands. Vern Jones Oil & Gas Corporation (Vern Jones) and Daniel L. Pickrell (Pickrell) are the successors in interest to Shell Oil Company. Vern Jones is the operator of record. Production ceased from the wells that gave rise to the drainage in 1996, and the wells have since been abandoned.

The Commission's Long Beach office staff has received two documents entitled Quitclaim of Compensatory Agreement PRC 3650.1 (attached hereto as Exhibit B). One document is dated January 13, 2010 and is signed by Vern Jones, and the other document is dated February 3, 2010 and signed by the trustee of the estate of Pickrell. Collectively, both documents release, remise and forever quitclaim unto the State, all right, title and interest in and to Agreement PRC 3650.1.



#### **QUITCLAIM OF COMPENSATORY AGREEMENT PRC 3650.1**

Compensatory Agreement Easement 3650.1 (Agreement), covering certain state lands underlying San Joaquin River and associated water courses in the Gill Ranch Gas Field in Madera and Fresno Counties, California, was issued October 1, 1966, between the State of California, acting through the California State Lands Commission (State) and Shell Oil Company (Shell). The Agreement was amended effective June 1, 1992 by the Daniel L. Pickrell (Pickrell) and Vern Jones Oil & Gas Corporation (Vern Jones), successors in interest to Shell.

Paragraph 6 of the Agreement permits the parties to terminate the Agreement by mutual consent. Section 6804.1 of the Public Resources Code permits Pickrell and Vern Jones, as the holders of the Agreement, to quitclaim all of their rights under the Agreement. Acting pursuant to these provisions, Pickrell and Vern Jones, collectively release, remise and forever quitclaim unto the State, all of their right, title and interest in and to the Agreement.
