CONTINUATION OF RENT

LESSEE:

Kern River Gas Transmission Company
2755 E. Cottonwood Parkway, Suite 300
Salt Lake City, UT 84121

AREA, LAND TYPE, AND LOCATION:

6.080 acres, more or less, of State school land in a portion of Section 16,
Township 17 North, Range 14 East, SBM, near Daggett, San Bernardino County.

AUTHORIZED USE:

Operation, use, and maintenance of an existing 36-inch diameter natural gas
pipeline as shown on the attached Exhibit A.

LEASE TERM:

30 years, beginning March 7, 1991.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease
term. Pursuant to this provision, staff conducted a review of the rent under this
lease, and recommends rent be continued at \$4,292 per year, effective
March 7, 2012.

OTHER PERTINENT INFORMATION:

On March 6, 1991, the Commission authorized a 30-year General Lease - Right-
of-Way Use with Kern River Gas Transmission Company. That lease will expire
on March 6, 2021. The Kern River Gas Transmission Company completed their
inspection of the natural gas pipeline in March 2011. The inspection was
performed using an in-line inspection device (smart pig). No violations were
reported.




SITE
