#### **REVISION OF RENT**

#### LESSEE:

Crockett Striped Bass Club P.O. Box 58 Crockett, CA 94525

### AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Carquinez Strait, near the town of Crockett, Contra Costa County

#### **AUTHORIZED USE:**

The continued use and maintenance of existing piers, dock, float, and buildings as shown on Exhibit A.

#### LEASE TERM:

20 years, beginning July 19, 2007.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$5,350 per year to \$7,860 per year, effective July 19, 2012.

#### OTHER PERTINENT INFORMATION:

- On May 10, 2007, the Commission authorized a General Lease Recreational Use to the Crockett Striped Bass Club, for a term of 20 years. The lease will expire on July 18, 2027.
- 2. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).




