**REVISION OF RENT**

**LESSEE:**

Larry T. Shaw

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in the Georgiana Slough, adjacent to 17219 Terminous Road, near the city of Isleton, Sacramento County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing covered floating boat dock with boat hoist and floating storage area, four wood pilings, ramp, and bank protection.

**LEASE TERM:**

10 years, beginning September 13, 2007.

**CONSIDERATION:**

This lease provides that State may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends rent be revised from \$52 per year to \$65 per year for the storage area, effective September 13, 2012.

**OTHER PERTINENT INFORMATION:**

1. On September 13, 2007, the Commission authorized a General Lease – Recreational Use to Larry T. Shaw, for a term of 10 years. The Lease will expire on September 12, 2017. The storage area is not used for the docking and mooring of boats and is subject to rent.
2. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

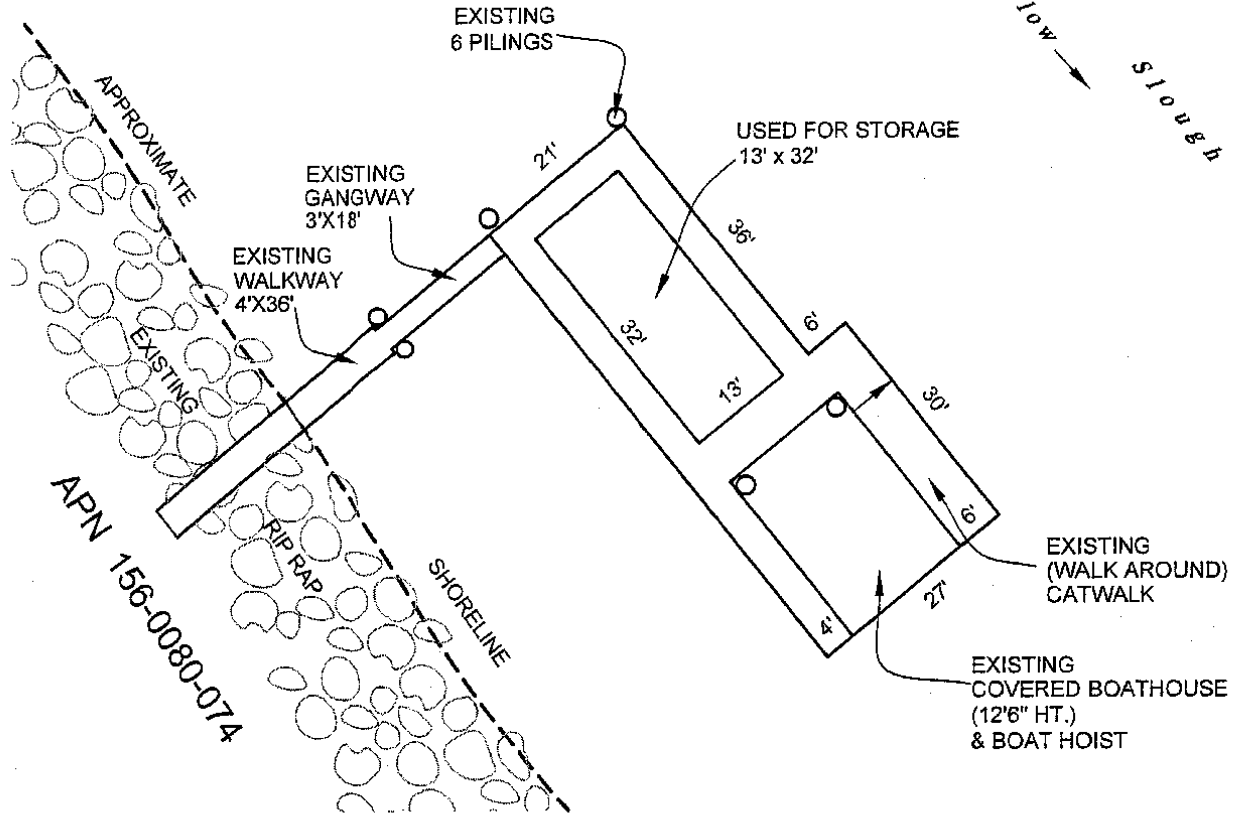
