### **GENERAL LEASE - PUBLIC AGENCY USE**

### APPLICANT:

United States Department of the Navy 2370 McKean Street, B 291 San Diego, CA 92136

### AREA, LAND TYPE, AND LOCATION:

Filled sovereign land located at North Island, adjacent to the Pacific Ocean, near the city of Coronado, San Diego County.

### **AUTHORIZED USE:**

Continued operation, use, and maintenance of four existing fenced airplane approach lights at the United States Naval Air Station.

### LEASE TERM:

20 Years, beginning February 28, 2012.

### CONSIDERATION:

The public use and benefit; with the State reserving the right at any time to set a monetary rent if the Commission finds such action to be in the State's best interest.

### OTHER PERTINENT INFORMATION:

- 1. Applicant owns the upland adjoining the lease premises.
- 2. On February 28, 1963, the Commission authorized an easement to the Department of Navy for the construction, operation, and maintenance of four fenced airplane approach lights for Runway 29 at the North Island Naval Air Station. That lease expired February 27, 2012. The applicant has now applied for a General Lease Pubic Agency Use.
- 3. The lease area is located within historic tide and submerged lands that were subject to fill and artificial accretion.

- 4. The approach lighting is part of a system aimed to give approaching aircraft the required information for a safe landing. The subject approach lights are used to assist aircraft safely into the North Island Naval Air Station which services 16 helicopter squadrons, 2 fixed wing squadrons, two aircraft carriers, four SEAL Teams, Navy Expeditionary Combat Command squadrons, and other air, surface, and subsurface commands.
- 5. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Cal. Code Regs., tit. 14, § 15061), the staff has determined that this activity is exempt from the requirements of CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

6. This activity involves lands which have NOT been identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq.; however, the Commission has declared that all lands are "significant" by nature of their public ownership (as opposed to "environmentally significant"). Since such declaration of significance is not based upon the requirements and criteria of Public Resources Code section 6370 et seq., use classifications for such lands have not been designated. Therefore, the finding of the project's consistency with the use classification as required by California Code of Regulations, Title 2, section 2954 is not applicable.


