#### **REVISION OF RENT**

#### LESSEE:

Bidwell Ranches, Inc.

#### AREA, LAND TYPE, AND LOCATION:

500 acres, more or less, of State school land in Section 16, Township 35 North, Range 5 East MDM, near Fall River Mills, Shasta County.

#### **AUTHORIZED USE:**

Livestock grazing.

#### **LEASE TERM:**

10 years, beginning February 5, 2005.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that rent be revised from \$500 per year to \$784 per year, effective February 5, 2013.

#### OTHER PERTINENT INFROMATION:

- On September 13, 2007, the Commission authorized a General Lease -Grazing Use with Bidwell Ranches, Inc.. That lease will expire on February 4, 2015.
- The number of animals permitted on the lease premises is restricted to that which can be supported by available forage and water, taking into account the forage and water reserved for necessary wildlife use. The available carrying capacity of the lease premises is estimated to be 56 animal unit months. The actual carrying capacity may vary due to climatic conditions. The Lessee has exercised good grazing practices and avoids over grazing.

3. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).




