LESSEE:

Sunnyside Lane, LLC, a California Limited Liability Company

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 2340 Sunnyside Lane, near Tahoe City, Placer County.

AUTHORIZED USE:

Continued use and maintenance of an existing pier, two boat slips, and two mooring buoys.

LEASE TERM:

10 years, beginning August 21, 2006.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$5,152 per year, effective August 21, 2012.

OTHER PERTINENT INFORMATION:

- 1. On October 30, 2007, the Commission authorized a General Lease Recreational Use with Sunnyside Lane, LLC, a Limited Liability Company, for the continued use and maintenance of an existing pier, two boat slips, and two mooring buoys. That lease will expire on August 20, 2016.
- 2. The staff recommends that the Commission find that the subject continuation of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).


