## **CONTINUATION OF RENT**

## **LESSEES:**

George C. Everett, Jr. and Andrea C. Everett, Trustees of the Everett Family Trust dated April 18, 1996

#### AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 8690 Brockway Vista, near Kings Beach, Placer County.

#### **AUTHORIZED USE:**

Continued use and maintenance of an existing pier, two mooring buoys, and a breakwater.

#### LEASE TERM:

10 years, beginning July 15, 2007.

#### CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be continued at \$965 per year, effective July 15, 2012.

#### OTHER PERTINENT INFORMATION:

- 1. On March 25, 2008, the Commission authorized a General Lease Recreational and Protective Structure Use with George C. Everett, Jr. and Andrea C. Everett, Trustees of the Everett Family Trust dated April 18, 1996, for the continued use and maintenance of an existing pier, two mooring buoys, and a breakwater. That lease will expire on July 14, 2017.
- 2. Under the terms of the lease, the breakwater is the only portion of the authorized improvements subject to annual rent. Staff recommends that rent be continued at the same rate.

3. The staff recommends that the Commission find that the subject continuation of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).




#### **CEQA FINDING:**
