CONSIDER ACCEPTANCE OF THE FULL QUITCLAIM DEED FOR NEGOTIATED SUBSURFACE (NO SURFACE USE) STATE OIL AND GAS LEASE NO. PRC 7976.1, NURSE SLOUGH, SOLANO COUNTY

AREA, LAND TYPE AND LOCATION:

Negotiated subsurface (no surface use) State Oil and Gas Lease No. PRC 7976.1 (Lease PRC 7976.1) contains approximately 42 acres of tide and submerged land in the bed of Nurse Slough (also known as Luco Slough) situated in Solano County, California (see Exhibit A attached hereto).

BACKGROUND:

On July 11, 1997, the California State Lands Commission (Commission) and McFarland Energy Company (80%) and Santa Barbara Resources, Inc. (20%) entered into Lease PRC 7976.1. On January 29, 1999, McFarland Energy Company assigned all of its interest to Slawson Exploration Company, Inc. (Slawson).

Slawson diligently pursued drilling activities to make PRC 7976.1 a productive lease. On June 18, 2002, the Commission granted a one-year extension of the drilling term to enable Slawson time to accomplish this goal; however, the lease never became productive.

CALENDAR ITEM NO. C88 (CONT'D)

Public Resources Code section 6804.1 and Lease Paragraph 30 permit the lessee to make, at any time, a written quitclaim of all rights under the lease or of any portion of the leased lands comprising a 10-acre parcel or multiple thereof in a compact form. The quitclaim will be effective when it is filed with the State subject to the continued obligation of the lessees and its surety to pay all accrued rentals and royalties.

On July 9, 2012, the Commission's Long Beach office staff received the document "(Full) Quitclaim Deed for State Oil and Gas Lease" from Slawson and Santa Barbara Resources. This document was dated June 1, 2012, and quitclaims back to the State all of the lessees' right, title and interest in the leased lands described in Exhibit A.

A review of the Commission's files reveals that no default exists on the Lease that the lessees have complied with all applicable laws and Lease provisions and have paid all rentals.




