REVISION OF RENT

LESSEE:

Walnut Grove Homeowners and Merchants Association

AREA, LAND TYPE, AND LOCATION:

Sovereign land in the Sacramento River, Walnut Grove, Sacramento County.

AUTHORIZED USE:

Continued use and maintenance of a guest dock, gangway, concrete access ramps, and landings.

LEASE TERM:

20 years, beginning February 20, 1998.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the minimum annual rent be revised from \$287 per year to \$312 per year against five percent of annual gross income derived on the lease premises, effective February 20, 2013.

OTHER PERTINENT INFORMATION:

- 1. On February 27, 1998, the Commission authorized a General Lease Commercial Use, with Walnut Grove Homeowners and Merchants Association. That lease will expire on February 19, 2018. Staff conducted the rent review called for in the lease and recommends that the minimum annual rent be increased.
- 2. The dock is open to the public free of charge between the hours of six a.m. and nine p.m. daily and the Lessee only charges rent for vessels moored overnight.
- 3. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a

reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).




SACRAMENTO RIVER
