REVISION OF RENT

LESSEE:

Southern California Edison Company
9500 Cleveland Avenue
c/o CRE, #100
Rancho Cucamonga, CA 91730

AREA, LAND TYPE, AND LOCATION:

0.038 acres, more or less, of sovereign land in Sunset Bay, near Seal Beach, Orange County.

AUTHORIZED USE:

Continued use and maintenance of an overhead electrical transmission line.

LEASE TERM:

49 years, beginning October 24, 1968.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$405 per year to \$479 per year, effective October 24, 2013

OTHER PERTINENT INFORMATION

1. On October 24, 1968, the Commission authorized a 49-year General Lease – Right-of-Way Use to Southern California Edison Company for an overhead electrical power line right-of-way occupying 0.038 acres of sovereign land in Sunset Bay near Seal Beach in Orange County. The facilities are located at a tidal crossing adjacent to the Sunset Aquatic Park.
2. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

CEQA FINDING:

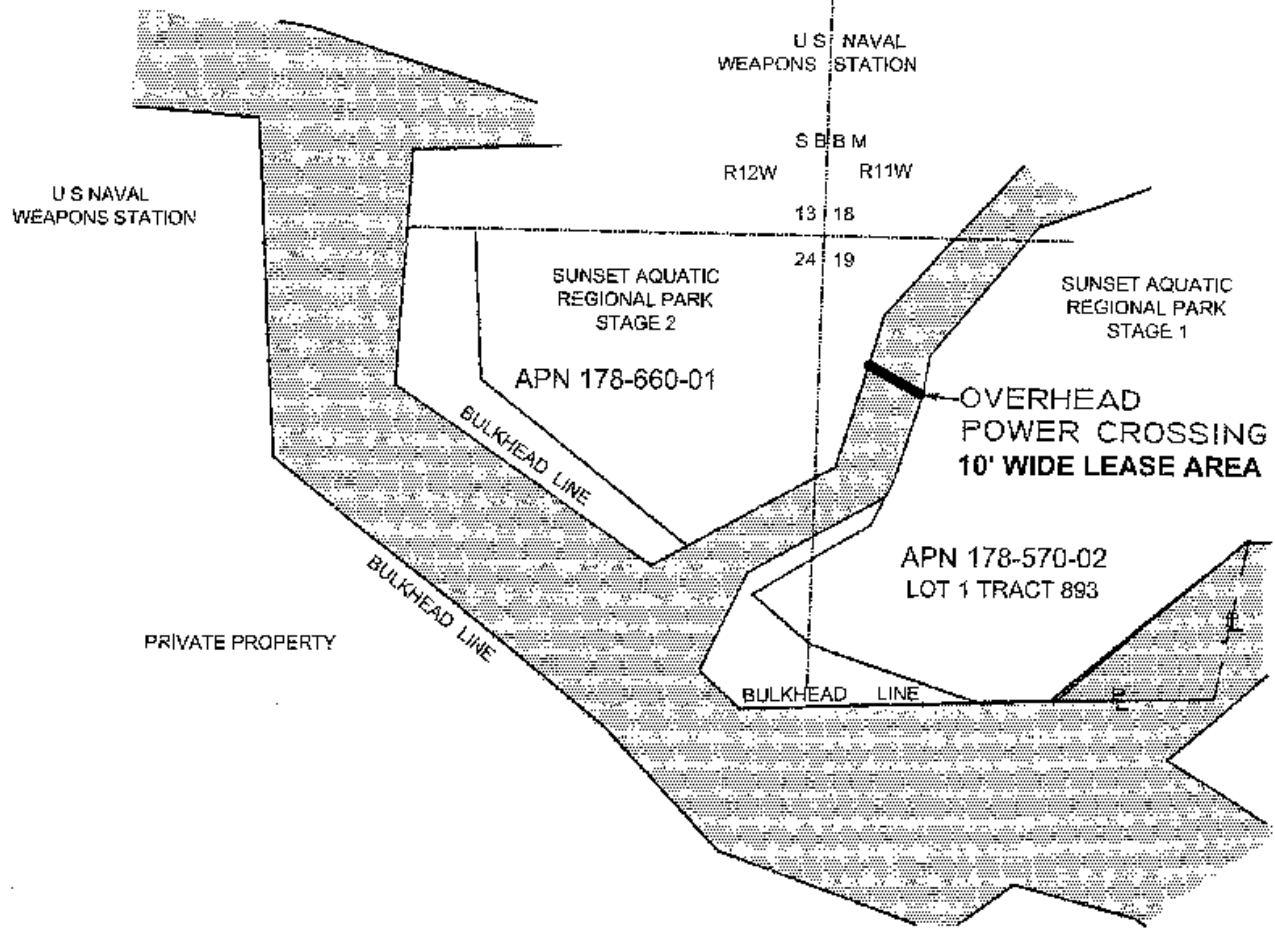
