#### **GENERAL LEASE - RECREATIONAL USE**

#### APPLICANTS:

Anna Young, Trustee of the Anna Young Trust Dated April 21, 1997; Cattarina Birgitta van den Toorn, as Trustee of the Cattarina Birgitta van den Toorn Separate Property Trust Dated December 2, 2002; and Linnea Alberta Bondoc, Trustee of the Linnea Alberta Bondoc Separate Property Trust Dated December 2, 2002

#### AREA, LAND TYPE, AND LOCATION:

0.038 acre, more or less, of sovereign land in the Petaluma River adjacent to 55 Havenwood Road, city of Novato, Marin County.

#### **AUTHORIZED USE:**

Continued use and maintenace of an existing raised walkway, access ramp, and an uncovered fixed boat dock for the mooring and docking of boats.

#### LEASE TERM:

10 years, beginning December 2, 2013

#### **CONSIDERATION:**

\$280 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

#### SPECIFIC LEASE PROVISIONS:

**Insurance**: Liability insurance in the amount of no less than \$1,000,000 per occurrence.

#### OTHER PERTINENT INFORMATION:

- 1. Applicants own the upland adjoining the lease premises.
- 2. On October 1, 2002, the Commission authorized the issuance of Lease No. PRC 3582.9, a Recreational Pier Lease to Anna B. Young, Cattarina van den Toorn, and Alberta Bondoc. That lease expired on May 26, 2012.

The Applicants are now applying for a new General Lease – Recreational Use.

3. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

#### **AUTHORIZATION:**

Authorize issuance of a General Lease - Recreational Use to Anna Young, Trustee of the Anna Young Trust Dated April 21, 1997,

Cattarina Birgitta van den Toorn, as Trustee of the Cattarina Birgitta van den Toorn Separate Property Trust Dated December 2, 2002, and Linnea Alberta Bondoc, Trustee of the Linnea Alberta Bondoc Separate Property Trust Dated December 2, 2002 beginning December 2, 2013, for a term of 10 years, for the continued use and maintenance of an existing raised walkway, access ramp, and an uncovered fixed boat dock for the mooring and docking of boats, as described in Exhibit A attached and by this reference made a part hereof, and as shown on Exhibit B (for reference purposes only); rent in the amount of \$280 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease; and liability insurance in the amount of no less than \$1,000,000 per occurrence.

TOGETHER WITH a 10' impact area.


EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the right bank of said river.





