### **GENERAL LEASE – RECREATIONAL USE**

### APPLICANT:

The Landing Homeowners Association

### AREA, LAND TYPE, AND LOCATION:

Sovereign land in Corte Madera Creek, adjacent to Assessor Parcel Numbers 022-550-01 through 07, near Greenbrae, Marin County.

### **AUTHORIZED USE:**

Continued use and maintenance of an existing floating boat dock and walkway previously authorized by the Commission; and use and maintenance of a gangway and two pilings not previously authorized by the Commission.

### LEASE TERM:

10 years, beginning December 2, 2013.

### CONSIDERATION:

\$154 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

### SPECIFIC LEASE PROVISIONS:

Liability insurance in the amount of no less than \$1,000,000 per occurrence.

### OTHER PERTINENT INFORMATION:

- 1. Lessee is an unincorporated association comprised of homeowners of the adjacent upland condominium.
- 2. On December 3, 1999, the Commission authorized a Recreational Pier Lease with the Applicant. That lease expired on May 31, 2009. The Applicant is now applying for a new General Lease Recreational Use.
- 3. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1,

TOGETHER WITH a 10' impact area.


