AREA, LAND TYPE, AND LOCATION:

5.56 acres, more or less, of sovereign lands in the Pacific Ocean, near the community of Los Osos, San Luis Obispo County.

AUTHORIZED USE:

Continued use and maintenance of a fiber optic cable contained within a five-inch diameter steel conduit that is a portion of Segment 5 of the AT&T Asia-America Gateway (AAG) fiber optic system.

LEASE TERM:

10 years, beginning March 2, 2009.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$65,400 per year to \$70,996 per year, effective March 2, 2014.

OTHER PERTINENT INFORMATION

- On March 2, 2009, the Commission authorized a ten-year General Lease

 Right of way Use with AT&T Corporation, for the installation, use and maintenance of a portion of Segment 5 of the AT&T Asia America
 Gateway fiber optic cable to be placed into an existing five-inch diameter steel conduit; the lease commenced on March 2, 2009.




