**CONSIDER APPROVAL OF A NON-EXCLUSIVE  
GEOLOGICAL SURVEY PERMIT ON SOVEREIGN LANDS  
UNDER THE JURISDICTION OF THE  
CALIFORNIA STATE LANDS COMMISSION**

**BACKGROUND:**

The geological surveys authorized under the terms of the permit are for the purpose of obtaining shallow samples adjacent to the Colorado River for geotechnical information. The data obtained are used in the study of nearshore soil and groundwater profiles for expansion of a Lower Colorado River Wildlife Habitat Area. Collected geotechnical data will be used in reopening an historic abandoned backwater river channel for habitat restoration. Fifteen (15) backhoe pits to a maximum of twenty-five (25) feet deep will be dug using a CAT 320 Excavator at locations shown on Exhibit A, attached hereto. The test pits will be logged, photographed, surveyed, backfilled, and compacted. Soil samples will be collected and classified as needed. Upon request, the California State Lands Commission will receive copies of all data derived from any and all surveys under the permit.

**TERMS OF PROPOSED PERMIT:**

Initial period:  
Three months beginning May 1, 2014, through July 31, 2014.

**PREREQUISITE CONDITIONS, FEES AND EXPENSES:**

Required fees, expense deposit and other security have been received.

**OTHER PERTINENT INFORMATION:**

1. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 6, Information Collection; California Code of Regulations, Title 2, section 2905, subdivision (e)(3).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
