**GENERAL LEASE – RECREATIONAL USE**

**APPLICANTS:**

Bertha Gaehwiler and Heidi Anne Gaehwiler Barberini, as trustees of the John R. Gaehwiler and Bertha Gaehwiler 1997 Trust – Survivor’s Trust

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in Lake Tahoe, adjacent to 3700 North Lake Boulevard, Carnelian Bay, Placer County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing pier and two mooring buoys.

**LEASE TERM:**

10 years, beginning August 28, 2014.

**CONSIDERATION:**

\$1,091 per year, with an annual Consumer Price Index (CPI) adjustment.

**SPECIFIC LEASE PROVISIONS:**

Insurance:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

Other:

1. The proposed lease contains a provision requiring the Applicants to obtain authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoys within two years after the adoption of a Final Environmental Impact Statement (FEIS) for the Lake Tahoe Shorezone Ordinance Amendments and approval of the amended ordinances. This is a continuation of the process the Commission used from approximately 1995 to October 2008 when TRPA adopted an FEIS and Ordinance Amendments supported by the FEIS. In September 2010, the U.S. District Court invalidated the FEIS and nullified the Amendments. When additional information is available, Commission staff will advise the Commission on any suggested modifications to the process used by the Commission

pending resolution of the TRPA FEIS and amended ordinance issues.

2. Lessee expressly acknowledges and agrees that issuance of a lease does not substitute for, or provide preference in, obtaining authorizations from TRPA or any other regulatory agency for the improvements authorized by the Commission.

**OTHER PERTINENT INFORMATION:**

1. Applicants own the upland parcel adjoining the lease premises.
2. On June 26, 2006, the Commission authorized a 10-year Recreational Pier Lease to John R. Gaehwiler and Bertha Gaehwiler, Trustees of the Gaehwiler Family 1997 Trust, for an existing pier and two mooring buoys. That lease expired on August 27, 2014. John R. Gaehwiler passed away on March 5, 2011. Subsequently, his interests were deeded to the Survivor's Trust for the benefit of Bertha Gaehwiler and Heidi Anne Gaehwiler Barberini, as trustees of the John R. Gaehwiler and Bertha Gaehwiler 1997 Trust – Survivor's Trust. The Applicants are now applying for a General Lease – Recreational Use.
3. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

**RECOMMENDED ACTION:**

It is recommended that the Commission:

**CEQA FINDING:**

Find that the activity is exempt from the requirements of CEQA pursuant to California Code of Regulations, Title 14, section 15061 as a categorically exempt project, Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

**SIGNIFICANT LANDS INVENTORY FINDING:**

Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code section 6370 et seq.

**AUTHORIZATION:**

Authorize issuance of a General Lease – Recreational Use to Bertha Gaehwiler and Heidi Anne Gaehwiler Barberini, as trustees of the John R. Gaehwiler and Bertha Gaehwiler 1997 Trust – Survivor’s Trust beginning August 28, 2014, for a term of 10 years, for the continued use and maintenance of an existing pier and two mooring buoys as described in Exhibit A and shown on Exhibit B (for reference purposes only) attached and by this reference made a part hereof; annual rent in the amount of \$1,091, with an annual Consumer Price Index adjustment; and liability insurance in an amount no less than \$1,000,000 per occurrence.

**LAND DESCRIPTION**

Three (3) parcels of submerged land, situate in the bed of Lake Tahoe, lying adjacent to fractional Section 28, Township 16 North, Range 17 East, MDM, as shown on the Official Township Plat, approved November 10<sup>th</sup>, 1865, County of Placer, State of California, and more particularly described as follows:

**PARCEL 1 – PIER**

All those lands underlying an existing pier and catwalk adjacent to those lots as described in Exhibit A of that Grant Deed recorded January 4<sup>th</sup>, 2013 in Document No. 2013-0001122 in Official Records of said County.

TOGETHER WITH any applicable impact area(s).

EXCEPTING THEREFROM any portion lying landward of the elevation of 6223 feet LTD along the shoreline of Lake Tahoe.

**PARCELS 2 & 3 – MOORING BUOYS**

Two (2) circular parcels of land, being 50 feet in diameter, underlying existing buoys, adjacent to those lots as described in Exhibit A of that Grant Deed recorded January 4<sup>th</sup>, 2013 in Document No. 2013-0001122 in Official Records of said County.

Accompanying plat is hereby made a part of this description.





LAND DESCRIPTION PLAT


