GENERAL LEASE – RECREATIONAL USE

APPLICANT:

Christine Cleese Carlson and Michael Edward Broadwater, Trustees of the Carlson-Broadwater Living Trust, dated November 2, 2007

AREA, LAND TYPE, AND LOCATION:

Sovereign land located in the Steamboat Slough, adjacent to 3447 Snug Harbor Drive, Walnut Grove, Solano County.

AUTHORIZED USE:

Continued use and maintenance of an existing floating boat dock, gangway, and cable anchors.

LEASE TERM:

10 years, beginning February 20, 2015

CONSIDERATION:

\$125 per year, with an annual Consumer Price Index adjustment.

SPECIFIC LEASE PROVISIONS:

Liability insurance in an amount no less than \$1,000,000 per occurrence.

OTHER PERTINENT INFORMATION:

1. Applicant owns the upland adjoining the lease premises.
2. The existing dock facilities were constructed by the previous owner and have existed at this location for many years, but were not previously authorized by the Commission. The Applicant is now applying for a General Lease – Recreational Use. Staff recommends bringing the existing facilities under lease.
3. The staff recommends that the Commission find that this activity is exempt from the requirements of the California Environmental Quality Act (CEQA) as a categorically exempt project. The project is exempt under Class 1,

Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

Authority: Public Resources Code section 21084 and California Code of Regulations, Title 14, section 15300 and California Code of Regulations, Title 2, section 2905.

4. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code section 6370 et seq., but such activity will not affect those significant lands. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

RECOMMENDED ACTION:

It is recommended that the Commission:

CEQA FINDING:

Find that the activity is exempt from the requirements of CEQA pursuant to California Code of Regulations, Title 14, section 15061 as a categorically exempt project, Class 1, Existing Facilities; California Code of Regulations, Title 2, section 2905, subdivision (a)(2).

SIGNIFICANT LANDS INVENTORY FINDING:

Find that this activity is consistent with the use classification designated by the Commission for the land pursuant to Public Resources Code section 6370 et seq.

AUTHORIZATION:

Authorize issuance of a General Lease – Recreational Use to Christine Cleese Carlson and Michael Edward Broadwater, Trustees of the Carlson-Broadwater Living Trust, dated November 2, 2007, beginning February 20, 2015, for a term of 10 years, for continued use and maintenance of an existing floating boat dock, gangway, and cable anchors, as described in Exhibit A and shown on Exhibit B (for reference purposes only), attached and by this reference made a part hereof; consideration: \$125 per year, with an annual Consumer Price Index adjustment; liability insurance in an amount no less than \$1,000,000 per occurrence.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of said Steamboat Slough.

Accompanying plat is hereby made part of this description.




