ASSIGNMENT OF LEASE

LESSEE/ASSIGNOR:

Silver Blue Lodge, LLC, a California Limited Liability Company

ASSIGNEE:

North Forty Bay, LLC, a California Limited Liability Company

AREA, LAND TYPE, AND LOCATION:

Sovereign land in Lake Tahoe, adjacent to 4784 North Lake Boulevard, near Carnelian Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of two existing mooring buoys.

LEASE TERM:

10 years, beginning April 23, 2014.

CONSIDERATION:

\$754 per year, with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in an amount no less than \$1,000,000 per occurrence. Other:

 If Lessee does not have valid Tahoe Regional Planning Agency (TRPA) buoy permits, Lessee is required to obtain such authorization for the mooring buoys within two years after the adoption of a Final Environmental Impact Statement (FEIS) for the Lake Tahoe Shorezone Ordinance Amendments and approval of the amended ordinances. If Lessee is unable to obtain such authorization within the time limit, they must remove the buoys.

2. Lessee expressly acknowledges and agrees that issuance of a lease does not substitute for, or provide preference in, obtaining authorizations from TRPA or any other regulatory agency for the improvements authorized by the Commission.

OTHER PERTINENT INFORMATION:

- 1. Assignee owns the upland adjoining the lease premises.
- On April 23, 2014, the Commission authorized a General Lease -Recreational Use with Silver Blue Lodge, LLC, a California Limited Liability Company, for two existing mooring buoys. That lease will expire on April 22, 2024. On January 16, 2015, the upland parcel was deeded to North Forty Bay, LLC, a California Limited Liability Company. The Applicant is now applying for an assignment of the lease.
- 3. The staff recommends that the Commission find that the subject lease assignment does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).









LAND DESCRIPTION PLAT PRC 8476.1, NORTH FORTY BAY, LLC PLACER COUNTY
