**REVISION OF RENT**

**LESSEE:**

San Joaquin Delta Power Squadron

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in San Joaquin River, adjacent to Headreach Island, near the city of Stockton, San Joaquin County.

**AUTHORIZED USE:**

Continued use and maintenance of an existing floating boat dock with southern and eastern extensions, one concrete pad with a wooden platform and a patio roof, one concrete pad with barbeque grills, ten pilings, gangway, ramp, three speed control signs, and a retaining wall.

**LEASE TERM:**

15 years, beginning August 11, 2009.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$1,194 per year to \$1,213 per year, effective August 11, 2015.

**OTHER PERTINENT INFORMATION:**

1. On August 11, 2009, the Commission authorized a 15-year General Lease – Recreational and Protective Structure Use to San Joaquin Delta Power Squadron. That lease will expire August 10, 2024.
2. Staff conducted the rent review called for in the lease and recommends the rent be increased to \$1,213 per year, effective August 11, 2015.
3. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and

is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).


