**REVISION OF RENT**

**LESSEE:**

Ann W. Baker, Trustee of the Baker Trust Dated 09/2/1987

**LAND, TYPE, AND LOCATION:**

0.01 acre, more or less, of sovereign land in the Pacific Ocean below 219 Pacific Avenue, city of Solana Beach, San Diego County.

**AUTHORIZED USE:**

The retention, use, and maintenance of an existing seacave/notch infill, and the construction, use, and maintenance of a portion of a new 35-foot high by 256-foot long seawall at the base of the bluff below 211-231 Pacific Avenue.

**LEASE TERM:**

10 years, beginning June 1, 2010.

**CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$3,208 per year to \$4,411 per year, effective June 1, 2015.

**OTHER PERTINENT INFORMATION:**

1. Lessee has the right to use the upland adjacent to the Lease Premises.
2. On August 20, 2010, the Commission authorized a General Lease – Protective Structure Use to Ann W. Baker, Trustee of the Baker Trust, for the retention, use, and maintenance of an existing seacave/notch infill, and the construction, use, and maintenance of a portion of a new 35-foot high by 256-foot long seawall. The lease will expire on May 31, 2020.
3. Staff has conducted the rent review called for in the lease and recommends the revision of rent.

4. Staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.

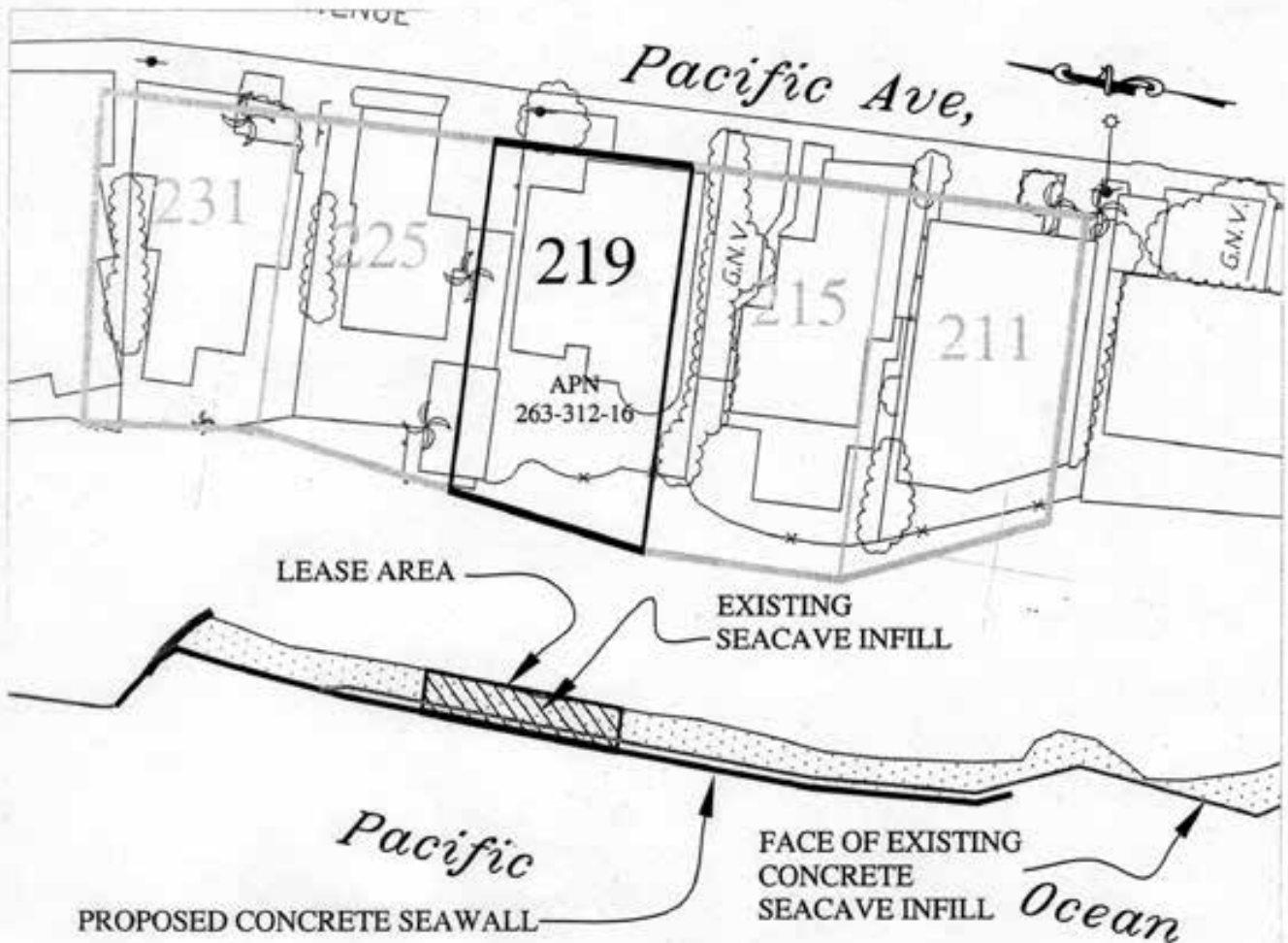
