### **REVISION OF RENT**

### LESSEE:

Pacific Gas and Electric Company P.O. Box 770000, Mail Code N10A San Francisco, CA 94177

### LAND, TYPE, AND LOCATION:

0.206 acre, more or less, of sovereign land in the bed of the Kings River adjacent to Fresno County Assessor's Parcel Numbers 365-072-13T, 19T, and 20T, in the city of Reedley, Fresno County.

### **AUTHORIZED USE:**

The retention, use, and maintenance of an existing 12kV overhead distribution line; and the reconstruction, use and maintenance of an existing 70kV overhead transmission line to a 115 kV overhead transmission line.

### LEASE TERM:

25 years, beginning June 28, 2010.

#### **CONSIDERATION:**

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff conducted a review of the rent under this lease and recommends that rent be revised from \$100 per year to \$450 per year, effective June 28, 2015.

### OTHER PERTINENT INFORMATION:

- 1. Lessee has the right to use the upland adjacent to the Lease Premises.
- 2. On June 28, 2010, the Commission authorized issuance of Lease No. PRC 8877.1, a General Lease Right-of-Way Use, to Pacific Gas and Electric Company for a previously unauthorized 70kV overhead transmission line and for the upgrade of that line to a new industry standard 115kV line as part of a larger project in the Fresno-Sanger-Reedley area of Fresno County.

- 3. On June 23, 2011, the Commission authorized an Amendment of Lease to include an existing 12kV overhead transmission line and to change the Land Description to reflect a new right-of-way alignment.
- 4. Staff has conducted the rent review called for in the lease and recommends the revision of rent.
- 5. Staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.




