REVISION OF RENT

LESSEE:

Southern California Gas Company
Land and Right of Way Department
555 W. 5th Street, GT11A1
Los Angeles, CA 90013-1032

AREA, LAND TYPE, AND LOCATION:

Sovereign land in and adjacent to the San Dieguito River, near the city of Del Mar, San Diego County.

AUTHORIZED USE:

Operation, use and maintenance of an existing 12-inch diameter natural gas pipeline, attached to the Camino Del Mar Bridge.

LEASE TERM:

25 years, beginning October 1, 2010.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$218 per year to \$545 per year, effective October 1, 2015.

OTHER PERTINENT INFORMATION:

1. The Lessee has a right to use the uplands adjoining the Lease Premises.
2. On October 29, 2010, the Commission authorized a General Lease – Right-of-Way Use to Southern California Gas Company for a 12-inch diameter natural gas pipeline. The lease will expire on September 30, 2035.
3. The existing 12-inch diameter natural gas pipeline is attached to the Camino Del Mar Bridge. The bridge is owned by the city of Del Mar and is under Lease No. PRC 8181.9. There is an additional 4-inch diameter

natural gas pipeline attached to the Camino Del Mar Bridge, which is under Lease No. PRC 8895.1 to San Diego Gas Company.

4. The Lessee is in compliance with state and federal pipeline safety regulations and is monitored through a comprehensive inspection and enforcement program. The Lessee conducts annual inspections on its pipeline. The 12-inch diameter natural gas pipeline was last inspected on March 23, 2015. No violations were reported.
5. Staff conducted the rent review called for in the lease and recommends that the rent be increased to \$545 per year, effective October 1, 2015.
6. The staff recommends that the Commission find that the subject revision of rent does not have a potential for resulting in either a direct or a reasonably foreseeable indirect physical change in the environment, and is, therefore, not a project in accordance with the California Environmental Quality Act (CEQA).

Authority: Public Resources Code section 21065 and California Code of Regulations, Title 14, sections 15060, subdivision (c)(3), and 15378.




SITE
