**REVISION OF RENT**

**LESSEE:**

City of Reedley

**AREA, LAND TYPE, AND LOCATION:**

Sovereign land in the Kings River, in the city of Reedley, Fresno County

**AUTHORIZED USE:**

Continued use and maintenance of a bridge with sewer and water main pipes, and utility conduits.

**LEASE TERM:**

20 years, beginning October 27, 2011.

**CONSIDERATION:**

This lease provides that lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease and recommends that rent be revised from \$384 per year to \$960 per year, effective October 27, 2016.

**OTHER PERTINENT INFORMATION:**

1. On March 29, 2012, the Commission authorized a General Lease – Public Agency Use to the City of Reedley for a term of 20 years, for the construction, use, and maintenance of a new bridge with sewer and water main pipes, and utility conduits crossing the Kings River and the endorsement of subleases for the utilities. The bridge is rent free because it provides a public use and benefit. The utility conduits are subject to annual rent. The lease will expire on October 26, 2031.
  
2. This action is consistent with Strategy 2.2 of the Commission’s Strategic Plan to ensure timely receipt of revenues and royalties from the use of State lands and minerals.

3. Approving the revision of rent is not a project as defined by the California Environmental Quality Act because it is an administrative action that will not result in direct or indirect physical changes in the environment.

Authority: Public Resources Code section 21065 and California Code of Regulations, title 14, section 15378, subdivision (b)(5).


