5 We only have one item on the agenda.

6 EXECUTIVE OFFICER DEDRICK: This is a request
7 for approval of amendment to Phillips Petroleum's oil and
8 gas lease on Lease Number 2933. The purpose of the
9 amendment is that Phillips is upgrading or increasing the
10 volume capacity of their onshore plant at Tajaigus in order
11 to handle the expected new volume from new discoveries on
12 the old lease. There is one well operating from the old
13 production period which pays the State roughly 21,000 a
14 month. Phillips has agreed to pay us an in-lieu royalty
15 of \$25,000 a month in order to shut in that well so that
16 they can upgrade the plant.

17 That's about it. All the usual guarantees
18 obtained. There are deadlines and so forth.

19 COMMISSIONER ORDWAY: How long will the construction
20 take?

21 EXECUTIVE OFFICER DEDRICK: Less than a year.

22 ACTING CHAIRPERSON RASMUSSEN: Any other questions?

23 COMMISSIONER ORDWAY: Anybody from Phillips who
24 wants to say anything?

25 EXECUTIVE OFFICER DEDRICK: Excuse me. One more
