14	EXECUTIVE OFFICER DEDRICK: Mr. Chairman, there is
15	one item I think we should move from the Consent Calendar to
16	the Regular Calendar, Item CC.
17	CHAIRMAN MCCARTHY: All right. Thank you.
18	Item C6 is moved to the regular calendar.
19	We will act now on the rest of the Consent Items
20	minus 1 and 6.
21	Without objection, they are approved.
22	Executive Officer's report.
23	EXECUTIVE OFFICER DEDRICK: Yes, Mr. Chairman, I
24	have two brief items.
25	The fire season did damage to four of our State

parcels. One of those parcels -- or three of those parcels were within the National Forests, and the cleanup work is being done in cooperation with the National Forest.

The other parcel, which was a severe fire resulting in injury and death to at least one CDF person, had to be cleaned up before that last series of rains arrived. Under the authority you nave delegated to the Executive Officer. I granted a contract for cleaning up the stream beds and so forth so rain damage would not occur there.

We're in the process of going to bid for the harvesting of from the down timber from the fire, what is salvageable, and I'll report back to you probably at the end of winter sometime when we know what has happened out there and come in for some other authorizations in that process.

If there are no questions?

CHAIRMAN MCCARTHY: Co ahead, please.

EXECUTIVE OFFICER DELRICK: The other item, we were directed to report back to you on the progress of the comprehensive study at the November meeting.

We have a brief report. It is before you.

Just to highlight it, the staff's efforts thus far have been largely directed toward collecting and reviewing the masses of existing material. That's a monumental task of pulling together all of the environmental research, coastal plans, all the background material for all of the things that

1 have been going on related to oil over the last ten years. 2 We would hope to go forward probably in January. We would be back to you in January with a recommended program 3 which we would then request that the Commission put out to the 5 public for comments before it's finally adopted. Is that an adequate report to you at this point?. 6 7 . CHAIRMAN McCARTHY: Commissioner Davis, is that sufficient to you? R All right. That's fine. 9 - Č) Thank you, very much. 10 11 What happened to the rest of the lights in this 12 place? Are we cutting down the overhead? I thought we had 13 lights in the back. 14 Okay. Itom what was C6. 15 Staff report, please. 16 EXECUTIVE OFFICER DEDRICK: Mr. Chairman, this item 17 is on the calendar as an approval and staff would now like to make it a denial. That's why we asked for it to be put on the 18 regular calendar. 19 A General Lease for Commercial Use for a proposed 20 21 Marina in Alviso Slough. We have not been able to reach the 22 applicant by phone to notify him of this change nor ware we able to reach him in order to get an 884 Extension if that 23 24 were a possibility. Next item. 28.

MR. HIGHT: 28, Mr. Chairman, ... the authorization to reorganize the land adjacent to Encinitae and Sulana Beach, and it will be annexed to the City of Solana Beach.

The Commission's role here is in approving the description and approving as a lead owner.

CHAIRMAN MCCARTHY: The land involved is only in these two cities.

MR. HIGHT: That's correct.

CHAIRMAN McCARTHY: Okay. Any questions? Approved as recommended.

29.

MR. HIGHT: 29 is the authorization to annex land to Dana Foint.

Last night, LAFCO -- there are two parcels. LAFCO decided that one parcel should go to Dana Point, and could not decide whether the other parcel should go to Dana Point or Laguna Niguel.

It is staff's recommendation: that the Commission authorize as landowner the Parcel A going to Dana Point, and that the Commission authorize as landowner the Jegal description of Exhibit B but not approve as landowner the annexation of that area because LAFCO at this point has not decided to which entity it should go.

There is supplemental language in your calendar 1 which will accomplish that effect. 2 CHAIRMAN McCARTHY: What is on the white sheet? MR. HIGHT: Yes. CHAIRMAN MCCARTHY: 3 and 4? MR. HIGHT: Yes. CHAIRMAN MCCARTHY: All right. Noved by Commissioner Davis. I second it. Any questions from the audience? Approved as recommended. 10 30. 11 MR. HIGHT: 30, Mr. Chairman, is a proposed title 12 settlement in the City of Vallejo. This parcel consists of 13 about four acres of land. The state will be receiving \$15,000 14 for its interest in the parcel. 15 This is a settlement and will allow for the sale of 16 the property. We have received two letters from local area 17 people concerned about the fact that Mr. Gianuling -- they're 18 questioning, I suppose, his general good citizenship in the 19 20 area. While staff does not have an opinion on that issue, 21 we believe that this settlement, as a whole, is in the best 22 interest of the State. It's a very good settlement for the 23 24 State. The staff of the Commission will be looking very 25

closely at any other activity that Mr. Gianulias has, and if 1 appropriate, we'll bring any other action as nacessary. 2 CHAIRMAN HCCARTHY: The applicant is here and 3 . apparently prepared to answer questions if we wish him th do so. Is there anyone in opposition to this? 5 Yes, Commissioner Davis. 6 COMMISSIONER DAVIS: I assume you're saying that 7 notwithstanding any other disputes that might exist in this 8 particular matter between the Commission and the applicant, 9 you recommend approval on this particular item. 10 MR. HIGHT: That's correct. 11 CHAIRMAN MCCARTHY: All right. 12 Any other pending disputes are to be settled one by 13 one, independently? 14 MR. HIGHT: Correct. 18 CHAIRMAN MCCARTHY: Any other comments on this? 16 All right. 17 Approved as recommended. 18 31. 19 MR. HIGHT: 31, Mr. Chairman, is the proposed 20 termination of an existing lease at Seal Beach and the 21 issuance of a new lease to Mr. Chang, doing business as Seal 22 Beach Gateway. 23 This is the for a hotel which will be placed on the 24 State's property in Seal Beach. In addition this settlement 25

is a settlement of a long standing problem. We have had a lease in the area for sometime, and hepefully, this new arrangement will allow the area to be built and used productively for the State.
