- 2 ACTING CHAIRPERSON BUGSCH: I'm Brian Bugsch
- 3 representing the Lieutenant Governor. And I'll call the
- 4 meeting of the State Lands Commission to order. Mr.
- 5 Thayer, this is a telephonic conference meeting, will you
- 6 call the roll of the Commissioners in attendance please?
- 7 EXECUTIVE OFFICER THAYER: Commissioner Sheehan?
- 8 ACTING COMMISSIONER SHEEHAN: Here.
- 9 EXECUTIVE OFFICER THAYER: Commissioner
- 10 Aronberg?
- 11 ACTING COMMISSIONER ARONBERG: Here.
- 12 EXECUTIVE OFFICER THAYER: Commissioner Bugsch?
- 13 ACTING CHAIRPERSON BUGSCH: Here.
- 14 EXECUTIVE OFFICER THAYER: Okay, we have a
- 15 quorum.
- 16 ACTING CHAIRPERSON BUGSCH: All right. The first
- 17 item of business will be the adoption of the minutes from
- 18 the Commissioner's last meeting. Can I have a motion to
- 19 approve the minutes.
- THE REPORTER: Who moved and seconded it?
- 21 EXECUTIVE ASSISTANT LUNETTA: We need people to
- 22 identify who's moving.
- 23 ACTING COMMISSIONER ARONBERG: I'm sorry. Cindy
- 24 makes the motion.
- 25 ACTING COMMISSIONER SHEEHAN: And Anne Sheehan

- 1 seconds it.
- 2 ACTING CHAIRPERSON BUGSCH: Okay. The minutes
- 3 are adopted.
- 4 The next order of business is the Executive
- 5 Officer's report. Mr. Thayer, may we have your report.
- 6 EXECUTIVE OFFICER THAYER: I have no report for
- 7 today.
- 8 ACTING CHAIRPERSON BUGSCH: Okay. The next order
- 9 of business is the consent calendar. Is there anyone in
- 10 the audience who wishes to speak on an item on the consent
- 11 calendar?
- 12 If not, the item with be taken up for a vote.
- 13 EXECUTIVE OFFICER THAYER: Yeah, go ahead.
- 14 ACTING CHAIRPERSON BUGSCH: Okay. We will now
- 15 proceed with a vote.
- 16 ACTING COMMISSIONER SHEEHAN: This is Anne
- 17 Sheehan. I will move adoption of Item C01, Riverbank
- 18 Holding Company application for a general lease.
- 19 ACTING COMMISSIONER ARONBERG: And this is Cindy.
- 20 I'll second Anne's motion.
- 21 ACTING CHAIRPERSON BUGSCH: Okay.
- 22 Is there anyone present at any locations that
- 23 wishes to address the Commission during the public comment
- 24 period?
- 25 MR. SLOAN: Yeah. This is Sheldon Sloan. I

1 would like to address just briefly, but not on this issue.

- 2 I don't want to delay the vote on this issue.
- 3 EXECUTIVE OFFICER THAYER: Yeah. No, the vote
- 4 has been taken, because the mover and second constitute a
- 5 majority.
- 6 MR. SLOAN: Okay. So you're onto public comment?
- 7 EXECUTIVE OFFICER THAYER: Yes.
- 8 MR. SLOAN: I just wanted to inquire what
- 9 progress has been made concerning the workshops that were
- 10 discussed at the last Commission meeting.
- 11 EXECUTIVE OFFICER THAYER: The staff has worked
- 12 through a couple of different proposed agendas, but we're
- 13 not finished with that process and we're looking to hold
- 14 meetings in May, June and July in San Francisco, San Diego
- 15 and the Los Angeles areas in probably that order. We'll
- 16 probably do the first one in the Bay Area, the second one
- 17 in San Diego and the third one in July -- in L.A.
- 18 MR. SLOAN: And I would just like to ask one more
- 19 question, will those meetings be specific to issues in the
- 20 local areas or will they be broad covering all issues in
- 21 all areas?
- 22 EXECUTIVE OFFICER THAYER: I think what we're
- 23 going to do is talk generally about the public trust
- 24 doctrine, and both from an educational perspective on our
- 25 behalf, but also to receive input from people in the local

- 1 areas. And probably in setting up the agendas, we will
- 2 focus, in addition to the general public trust discussion,
- 3 on items of interest to the local area.
- 4 MR. SLOAN: Thank you very much. That's a very
- 5 clear answer. I appreciate it.
- 6 EXECUTIVE OFFICER THAYER: Great.
- 7 ACTING COMMISSIONER SHEEHAN: Do you need a
- 8 motion for adjournment?
- 9 EXECUTIVE OFFICER THAYER: I don't think so.
- 10 MR. SKIDMORE: This is Kip Skidmore. I'm
- 11 representing Riverbank. I'd like to thank all the
- 12 commissioners for making this special effort to approve
- 13 our financing for Riverbank. It expired today if we
- 14 didn't take this action, so I appreciate Paul and the
- 15 commissioners' efforts to get this thing on the agenda.
- 16 And, again, I'd just like to thank you for your time.
- 17 ACTING COMMISSIONER ARONBERG: This is Cindy
- 18 Aronberg. We appreciate that, because we do try to be
- 19 customer-service oriented in keeping with this.
- 20 And Alan said that I could move adjournment if I
- 21 felt like, so I'm going to move for adjournment.
- 22 ACTING COMMISSIONER SHEEHAN: Anne Sheehan will
- 23 second.
- 24 ACTING CHAIRPERSON BUGSCH: Okay. Thank you for
- 25 the motion.
